1 Safety instructions and measures

Intended use

The SAMSON Type 3321 Globe Valve in combination with an actuator (e.g. Type 3371 Pneumatic Actuator, Type 3372 Electropneumatic Actuator, Type 5827 Electric Actuator or Type 3374 Electric Actuator) is designed to regulate the flow rate, pressure or temperature of liquids, gases or vapors. The valve with its actuator is designed to operate under exactly defined conditions (e.g. operating pressure, process medium, temperature). Therefore, operators must ensure that the control valve is only used in operating conditions that meet the specifications used for sizing the valve at the ordering stage. In case operators intend to use the control valve in applications or conditions other than those specified, contact SAMSON.

SAMSON does not assume any liability for damage resulting from the failure to use the device for its intended purpose or for damage caused by external forces or any other external factors.

→ Refer to the technical data and nameplate for limits and fields of application as well as possible uses.

Reasonably foreseeable misuse

The control valve is not suitable for the following applications:

- Use outside the limits defined during sizing and by the technical data
- Use outside the limits defined by the valve accessories connected to the valve
 Furthermore, the following activities do not comply with the intended use:
- Use of non-original spare parts
- Performing service and repair work not described

Qualifications of operating personnel

The control valve must be mounted, started up, serviced and repaired by fully trained and qualified personnel only; the accepted industry codes and practices must be observed. According to these mounting and operating instructions, trained personnel refers to individuals who are able to judge the work they are assigned to and recognize possible hazards due to their specialized training, their knowledge and experience as well as their knowledge of the applicable standards.

Work on electrical installations is to be performed only by certified electricians and in compliance with all safety requirements.

Safety instructions and measures

Personal protective equipment

SAMSON recommends checking the hazards posed by the process medium being used (e.g. GESTIS (CLP) hazardous substances database). Depending on the process medium and/ or the activity, the protective equipment required includes:

- Protective clothing, gloves, eye protection and respiratory protection in applications with hot, cold and/or corrosive media
- Wear hearing protection when working near the valve
- Hard hat
- Safety harness, e.g. when working at height
- Safety footwear, if applicable ESD (electrostatic discharge) footwear
- → Check with the plant operator for details on further protective equipment.

Revisions and other modifications

Revisions, conversions or other modifications of the product are not authorized by SAMSON. They are performed at the user's own risk and may lead to safety hazards, for example. Furthermore, the product may no longer meet the requirements for its intended use.

Safety features

The fail-safe position of the control valve upon air supply or control signal failure depends on the actuator used (see associated actuator documentation). When the valve is combined with one of the following SAMSON actuators, the valve moves to a certain fail-safe position (see the 'Design and principle of operation' chapter) upon supply air or control signal failure.

- Type 3371 Pneumatic Actuator
- Type 3372 Electropneumatic Actuator
- Type 3374 Electric Actuator (version with fail-safe action only)

The fail-safe action of the actuator is the same as its direction of action and is specified on the nameplate of SAMSON actuators.

Warning against residual hazards

To avoid personal injury or property damage, plant operators and operating personnel must prevent hazards that could be caused in the control valve by the process medium, the operating pressure, the signal pressure or by moving parts by taking appropriate precautions. Plant operators and operating personnel must observe all hazard statements, warnings and caution notes in these mounting and operating instructions.

Hazards resulting from the special working conditions at the installation site of the valve must be identified in a risk assessment and prevented through the corresponding safety instructions drawn up by the operator.

Responsibilities of the operator

Operators are responsible for proper use and compliance with the safety regulations. Operators are obliged to provide these mounting and operating instructions as well as the referenced documents to the operating personnel and to instruct them in proper operation. Furthermore, operators must ensure that operating personnel or third parties are not exposed to any danger.

Operators are additionally responsible for ensuring that the limits for the product defined in the technical data are observed. This also applies to the start-up and shutdown procedures. Start-up and shutdown procedures fall within the scope of the operator's duties and, as such, are not part of these mounting and operating instructions. SAMSON is unable to make any statements about these procedures since the operative details (e.g. differential pressures and temperatures) vary in each individual case and are only known to the operator.

Responsibilities of operating personnel

Operating personnel must read and understand these mounting and operating instructions as well as the referenced documents and observe the specified hazard statements, warnings and caution notes. Furthermore, operating personnel must be familiar with the applicable health, safety and accident prevention regulations and comply with them.

Referenced standards, directives and regulations

The control valves comply with the requirements of the European Pressure Equipment Directive 2014/68/EU, Machinery Directive 2006/42/EC, Directive 2016 No. 1105 Pressure Equipment (Safety) Regulations 2016 and Directive 2008 No. 1597 Supply of Machinery (Safety) Regulations 2008. Valves with a CE marking and/or UKCA marking have a declaration of conformity, which includes information about the applied conformity assessment procedure. The 'Certificates' chapter contains this declaration of conformity.

According to the ignition hazard assessment performed in accordance with Clause 5.2 of ISO 80079-36, the non-electrical control valves do not have their own potential ignition source even in the rare incident of an operating fault. As a result, they do not fall within the scope of Directive 2014/34/EU.

→ For connection to the equipotential bonding system, observe the requirements specified in Clause 6.4 of EN 60079-14 (VDE 0165-1).

1.1 Notes on possible severe personal injury

A DANGER

Risk of bursting in pressure equipment.

Valves and pipelines are pressure equipment. Excessive pressurization or improper opening can lead to valve components bursting.

- → Observe the maximum permissible pressure for valve and plant.
- → Before starting any work on the control valve, depressurize all plant sections affected as well as the valve.
- → Drain the process medium from the plant sections affected as well as from the valve

▲ DANGER

Risk of fatal injury due to electric shock from electrically powered components.

- → While working on electric devices or before opening the device, disconnect the supply voltage and protect it against unintentional reconnection.
- → Do not remove any covers to perform adjustment work on live parts.
- → Only use protective equipment that can be protected against unintentional reconnection of the power supply.
- → SAMSON electric actuators are protected against spray water. Avoid jets of water.
- → Observe all other safety instructions in the associated documentation of the electric device (e.g. electric actuator).

1.2 Notes on possible personal injury

A WARNING

Risk of burn injuries due to hot or cold components and pipelines.

Depending on the process medium, valve components and pipelines may get very hot or cold and cause burn injuries.

- Allow components and pipelines to cool down or warm up to the ambient temperature.
- → Wear protective clothing and safety gloves.

Risk of hearing loss or deafness due to loud noise.

The noise emissions depend on the valve version, plant facilities and process medium.

→ Wear hearing protection when working near the valve.

A WARNING

Risk of personal injury due to exhaust air being vented from pneumatically operated components.

While the valve is operating, the pneumatic actuator may vent during closed-loop control or when the valve opens or closes.

- → Install the control valve in such a way that vent openings are not located at eye level and the actuator does not vent at eye level in the work position.
- → Use suitable mufflers and vent plugs.
- → Wear eye protection when working in close proximity to the control valve.

Risk of personal injury due to preloaded springs in pneumatic actuators.

Valves in combination with pneumatic actuators with preloaded springs are under tension. These control valves with SAMSON pneumatic actuators can be identified by the long bolts protruding from the bottom of the actuator.

→ Before starting any work on the actuator, relieve the compression from the preloaded springs (see associated actuator documentation).

Crush hazard arising from moving parts.

The control valve contains exposed moving parts (actuator and plug stem), which can injure hands or fingers if inserted into the valve.

- → Do not insert hands or finger into the yoke while the air supply or voltage supply is connected to the actuator.
- → Before working on the control valve, disconnect and lock the pneumatic air supply and the control signal or disconnect the supply voltage and protect it against unintentional reconnection.
- → Do not impede the movement of the actuator and plug stem by inserting objects into the yoke.
- → Before unblocking the actuator and plug stem after they have become blocked (e.g. due to seizing up after remaining in the same position for a long time), release any stored energy in the actuator (e.g. spring compression). See associated actuator documentation.

A WARNING

Risk of personal injury due to residual process medium in the valve.

While working on the valve, residual medium can flow out of the valve and, depending on its properties, cause personal injury, e.g. (chemical) burns.

- → If possible, drain the process medium from the plant sections affected and from the valve.
- → Wear protective clothing, safety gloves, respiratory protection and eye protection.

Exposure to hazardous substances poses a serious risk to health.

Certain lubricants and cleaning agents are classified as hazardous substances. These substances have a special label and a material safety data sheet (MSDS) issued by the manufacturer.

- → Make sure that an MSDS is available for any hazardous substance used. If necessary, contact the manufacturer to obtain an MSDS.
- → Inform yourself about the hazardous substances and their correct handling.

Risk of personal injury due to incorrect operation, use or installation as a result of information on the valve being illegible.

Over time, markings, labels and nameplates on the valve may become covered with dirt or become illegible in some other way. As a result, hazards may go unnoticed and the necessary instructions not followed. There is a risk of personal injury.

- → Keep all relevant markings and inscriptions on the device in a constantly legible state
- → Immediately renew damaged, missing or incorrect nameplates or labels.

1.3 Notes on possible property damage

• NOTICE

Risk of valve damage due to contamination (e.g. solid particles) in the pipeline.

The plant operator is responsible for cleaning the pipelines in the plant.

→ Flush the pipelines before start-up.

NOTICE

Risk of valve damage due to unsuitable medium properties.

The valve is designed for a process medium with defined properties.

→ Only use the process medium specified for sizing the equipment.

Risk of leakage and valve damage due to over- or under-torquing.

Observe the specified torques when tightening control valve components. Excessive tightening torques lead to parts wearing out more quickly. Parts that are too loose may cause leakage.

→ Observe the specified tightening torques (► AB 0100).

Risk of valve damage due to the use of unsuitable tools.

Certain tools are required to work on the valve.

→ Only use tools approved by SAMSON (► AB 0100).

Risk of valve damage due to the use of unsuitable lubricants.

The lubricants to be used depend on the valve material. Unsuitable lubricants may corrode and damage surfaces.

→ Only use lubricants approved by SAMSON (► AB 0100).

Risk of the process medium being contaminated through the use of unsuitable lubricants and/or contaminated tools and components.

- → If necessary, keep the valve and the tools used free from solvents and grease.
- → Make sure that only suitable lubricants are used.

1.4 Warnings on the device



2 Markings on the device

The nameplate shown was up to date at the time of publication of this document. The nameplate on the device may differ from the one shown.

2.1 Valve nameplate

In nominal sizes DN 15 to 50 or NPS $\frac{1}{2}$ to 2, the valve nameplate (80) is affixed to the valve on the body flange (Fig. 2-1). The nameplate is affixed to the top of the bonnet in nominal sizes DN 65 or NPS $\frac{2}{2}$ and larger (Fig. 2-2).




Fig. 2-3: Inscriptions on the valve nameplate

Fig. 2-3 and the inscription table list all possible characteristics and options that may appear on a valve nameplate. Only the inscriptions relevant to the ordered Type 3321 Valve actually appear on the nameplate.

2.3 Material identification number

The seat and plug of the valves have an item number written on them. You can contact us stating this item number to find out which material is used. Additionally, a seat code is used to identify the trim material. This seat code is specified on the nameplate.

SAMSON recommends to include the device's serial number (22 on the nameplate) and/or its material number (as specified in the order confirmation) in the plant documentation for the associated tag number.

3 Design and principle of operation

The Type 3321 Valve is a single-seated globe valve. This valve is preferably to be combined with the following SAMSON actuators:


- Type 3371 Pneumatic Actuator
- Type 3372 Electropneumatic Actuator
- Type 3374 Electric Actuator
- Type 5827 Electric Actuator

The seat (4) and plug with plug stem (5) are installed in the body (1). The plug stem is


connected to the actuator stem (A3/A7) by a stem connector (A30/A31) and sealed by the spring-loaded packing (15).

The process medium flows through the valve in the direction indicated by the arrow in the flow-to-open direction. The plug position determines the cross-sectional area between the seat and plug.

The position of the plug is changed by the control signal acting on the actuator.

3.1 Fail-safe action

The fail-safe position of the control valve upon air supply or control signal failure depends on the actuator used (see associated actuator documentation). The fail-safe action of SAMSON actuators is specified on the actuator nameplate.

Upon supply voltage failure, the Type 3374 Electric Actuator (version with fail-safe action only) causes the valve to move to a certain fail-safe position.

Depending on how the compression springs are arranged in the SAMSON Type 3271 and Type 3277 Pneumatic Actuator, the valve has one of the following fail-safe positions:

Actuator stem extends (FA)

Upon supply voltage or air supply failure, the actuator stem extends causing the valve to close.

Actuator stem retracts (FE)

Upon supply voltage or air supply failure, the actuator stem extends causing the valve to open.

∵Ö- Tip

The direction of action of the electric and electropneumatic actuators is determined by the actuator version.

The direction of action of the Type 3371 Pneumatic Actuator can be reversed, if required. See the mounting and operating instructions ► EB 8317.

3.2 Versions

With insulating section

The modular design allows an insulating section to be fitted to the standard valve version.

Actuators

In these instructions, the preferable combination with one of the following SAMSON actuators is described.

- Type 5827 Electric Actuator
- Type 3374 Electric Actuator
- Type 3372 Electropneumatic Actuator
- Type 3371 Pneumatic Actuator

3.3 Additional fittings

Strainers

We recommend installing a SAMSON strainer upstream of the valve. It prevents solid particles in the process medium from damaging the valve.

Bypass and shut-off valves

We recommend installing a shut-off valve both upstream of the strainer and downstream of the valve and installing a bypass line. The bypass ensures that the plant does not need to be shut down for service and repair work on the valve.

Insulation

Control valves can be insulated to reduce heat energy transfer. Refer to the instructions in the 'Installation' chapter.

Design and principle of operation

Safety guard

For operating conditions that require increased safety (e.g. in cases where the valve is freely accessible to untrained staff), a safety guard must be installed to rule out a crush hazard arising from moving parts (actuator and plug stem). Plant operators are responsible for deciding whether a guard is to be used. The decision is based on the risk posed by the plant and its operating conditions.

Noise reduction

Trims with flow dividers can be used to reduce noise emission (► T 8081).

3.5 Technical data

The nameplates on the valve and actuator provide information on the control valve version. See the 'Markings on the device' chapter

Conformity

The Type 3321 Valve bears the CE, UKCA and EAC marks of conformity.



Temperature range

Depending on the version, the control valve is designed for a temperature range from -10 to +220 °C (14 to 430 °F).

The use of an insulating section can extend the temperature range to +300 °C (+572 °F) depending on the properties of the materials used

Leakage class

Depending on the version, the following leakage class applies:

Noise emissions

SAMSON is unable to make general statements about noise emissions. The noise emissions depend on the valve version, plant facilities and process medium.



4 Shipment and on-site transport

The work described in this chapter is to be performed only by personnel appropriately qualified to carry out such tasks.

4.1 Accepting the delivered goods

After receiving the shipment, proceed as follows:

- Check the scope of delivery. Check that the specifications on the valve nameplate match the specifications in the delivery note. See the 'Markings on the device' chapter for nameplate details.
- Check the shipment for transportation damage. Report any damage to SAMSON and the forwarding agent (refer to delivery note).
- Determine the weight and dimensions of the units to be lifted and transported in order to select the appropriate lifting equipment and lifting accessories, if required. Refer to the transport documents and the 'Technical data' chapter.

4.2 Removing the packaging from the valve

Observe the following sequence:

Do not open or remove the packaging until immediately before lifting to install the valve into the pipeline.

- → Leave the control valve in its transport container or on the pallet to transport it on site.
- → Do not remove the protective caps from the inlet and outlet until immediately before installing the valve into the pipeline. They prevent foreign particles from entering the valve.
- Dispose and recycle the packaging in accordance with the local regulations.

4.3 Transporting and lifting the valve

A DANGER

Danger due to suspended loads falling.

- → Stay clear of suspended or moving loads.
- → Close off and secure the transport paths.

A WARNING

Risk of lifting equipment tipping over and risk of damage to lifting accessories due to exceeding the rated lifting capacity.

→ Only use approved lifting equipment and accessories whose minimum lifting capacity is higher than the weight of the valve (including actuator and packaging, if applicable).



4.3.1 Transporting the valve

The control valve can be transported using lifting equipment (e.g. crane or forklift).

- → Leave the control valve in its transport container or on the pallet to transport it.
- → Observe the transport instructions.

Transport instructions

- Protect the control valve against external influences (e.g. impact).
- Do not damage the corrosion protection (paint, surface coatings). Repair any damage immediately.
- Protect the piping and any mounted valve accessories against damage.
- Protect the control valve against moisture and dirt.
- The permissible transportation temperature of standard control valves is -20 to +65 °C/-4 to +149 °F.

Contact our after-sales service for the transportation temperatures of other valve versions.

4.3.2 Lifting the valve

To install a large valve into the pipeline, use lifting equipment (e.g. crane or forklift) to lift it.

Lifting instructions

Use a hook with safety latch (see
 Fig. 4-1) to secure the slings from slip-

- ping off the hook during lifting and transporting.
- Secure slings against slipping.
- Make sure the slings can be removed from the device once it has been installed into the pipeline.
- Prevent the control valve from tilting or tipping over.
- Do not leave loads suspended when interrupting work for longer periods of time
- Make sure that the axis of the pipeline is always horizontal during lifting and the axis of the plug stem is always vertical.

Lifting the control valve

- 1. Attach one sling to each flange of the body and to the rigging equipment (e.g. hook) of the crane or forklift (see Fig. 4-1).
- Carefully lift the control valve. Check whether the lifting equipment and accessories can bear the weight.
- 3. Move the control valve at an even pace to the site of installation.
- 4. Install the valve into the pipeline (see the 'Installation' chapter).
- After installation in the pipeline, check whether the flanges are bolted tight and the valve in the pipeline holds.
- 6. Remove slings.

4.4 Storing the valve

NOTICE

Risk of valve damage due to improper storage.

- → Observe the storage instructions.
- → Avoid long storage times.
- Contact SAMSON in case of different storage conditions or longer storage times.

SAMSON recommends to regularly check the control valve and the prevailing storage conditions during long storage periods.

Storage instructions

- Protect the control valve against external influences (e.g. impact).
- Do not damage the corrosion protection (paint, surface coatings). Repair any damage immediately.
- Secure the valve in the stored position against slipping or tipping over.
- Protect the control valve against moisture and dirt. Store it at a relative humidity of less than 75 %. In damp spaces, prevent condensation. If necessary, use a drying agent or heating.
- Make sure that the ambient air is free of acids or other corrosive media.
- The permissible storage temperature of standard control valves is -20 to +65 °C/-4 to +149 °F. Contact our af-

- ter-sales service for the storage temperatures of other valve versions.
- Do not place any objects on the control valve.

Special storage instructions for elastomers

Elastomer, e.g. actuator diaphragm

- To keep elastomers in shape and to prevent cracking, do not bend them or hang them up.
- SAMSON recommends a storage temperature of 15 °C (59 °F) for elastomers.
- Store elastomers away from lubricants, chemicals, solutions and fuels.



5.1 Installation conditions

Work position

The work position for the control valve is the front view looking onto the operating controls (including valve accessories).

Installation

Plant operators must ensure that, after installation of the device, the operating personnel can perform all necessary work safely and easily access the device from the work position.

Pipeline routing

The inlet and outlet lengths (see Table 5-1) vary depending on several variables and process conditions and are intended as recommendations. Contact SAMSON if the lengths are significantly shorter than the recommended lengths.

To ensure that the valve functions properly, proceed as follows:

- → Observe the recommended inlet and outlet lengths (see Table 5-1). Contact SAMSON if the valve conditions or states of the medium process deviate.
- → Install the valve free of stress and with the least amount of vibrations as possible.

 Read information under "Mounting position" and "Fail-safe position with pneumatic actuators with integrated springs" in this chapter.
- → Install the valve allowing sufficient space to remove the actuator and valve or to perform service and repair work on them.

Mounting position

Generally, SAMSON recommends installing the valve with the actuator upright and on top of the valve.

Contact SAMSON if the mounting position is not as specified above.

Support or suspension

i Note

The plant engineering company is responsible for selecting and implementing a suitable support or suspension of the installed control valve and the pipeline.

Depending on the valve version and mounting position, the valve, actuator and pipeline must be supported or suspended.

Valves, which are not installed in the pipeline in the upright position with the actuator on top, must be supported or suspended.

Valve accessories

During connection of valve accessories, make sure that they are easily accessible and can be operated safely from the work position.

Vent plugs

Vent plugs are screwed into the exhaust air ports of pneumatic and electropneumatic devices. They ensure that any exhaust air that forms can be vented to the atmosphere (to avoid excess pressure in the device). Furthermore, the vent plugs allow air intake to prevent a vacuum from forming in the device.

→ Locate the vent plug on the opposite side to the work position of operating personnel.

5.2 Preparation for installation


Before installation, make sure the following conditions are met:

- The valve is clean.
- The valve and all valve accessories (including piping) are not damaged.
- The valve data on the nameplate (type designation, nominal size, material, pressure rating and temperature range) match the plant conditions (nominal size and pressure rating of the pipeline, medium temperature etc.). See the 'Markings on the device' chapter for nameplate details.
- The requested or required additional pipe fittings (see the 'Additional fittings' chapter) have been installed or prepared as necessary before installing the valve.

NOTICE

Risk of control valve damage due to incorrect insulation.

→ Only insulate control valves up to the bonnet flange of the valve body (see Fig. 5-1). This also applies to versions with insulating section at medium temperatures below 0 °C (32 °F) or above 220 °C (428 °F). If the insulating section is insulated, it will not function properly.



Proceed as follows:

- → Lay out the necessary material and tools to have them ready during installation work
- → Flush the pipelines.

i Note

The plant operator is responsible for cleaning the pipelines in the plant.

- → For steam applications, dry the pipelines.

 Moisture will damage the inside of the valve.
- → Check any mounted pressure gauges to make sure they function properly.
- → When the valve and actuator are already assembled, check the tightening torques of the bolted joints (► AB 0100). Components may loosen during transport.

5.3 Mounting the device

The activities listed below are necessary to install the valve and before it can be started up.

NOTICE

Risk of control valve damage due to overor under-torquing.

Observe the specified torques when tightening control valve components. Excessive tightening torques lead to parts wearing out more quickly. Parts that are too loose may cause leakage.

→ Observe the specified tightening torques (► AB 0100).

5.3.1 Mounting the actuator onto the valve

→ To mount the actuator, proceed as described in the associated actuator documentation

a) Pneumatic or electropneumatic actuator

There are two different types of attachment to mount the pneumatic or electropneumatic actuator onto the valve depending on the version (nominal size etc.): mounting using crossbeam or mounting using rods (see Table 5-2).

Mounting using crossbeam and central nut

When the actuator is mounted to the valve using a crossbeam (form B, Fig. 5-1), the actuator is fastened to the valve bonnet using a central nut.


Mounting using rods

When the actuator is mounted using rods (form C, Fig. 5-2), the actuator is connected to the valve bonnet using rods. In this case, a crossbeam is not required for mounting the actuator. A plate keeps the correct distance between rods.

b) Electric actuator

When an electric actuator is mounted onto the valve, it is mounted with a form-fit connection using a stem connector and yoke.

5.3.2 Installing the valve into the pipeline

- Close the shut-off valves in the pipeline at the inlet and outlet of the plant section while the valve is being installed.
- 2. Prepare the relevant section of the pipeline for installing the valve.
- 3. Remove the protective caps from the valve ports before installing the valve.
- 4. Lift the valve using suitable lifting equipment to the site of installation (see the 'Lifting the valve' chapter). Observe the flow direction through the valve. The arrow on the valve indicates the direction of flow.
- Make sure that the correct flange gaskets are used.
- 6. Bolt the pipe to the valve free of stress.
- 7. Attach a support or suspension on the valve, if necessary.

5.4 Testing the installed valve

A DANGER

Risk of bursting due to incorrect opening of pressurized equipment or components.

Valves and pipelines are pressure equipment that may burst when handled incorrectly. Flying projectile fragments or the release of process medium under pressure can cause serious injury or even death.

Before working on the control valve:

- Close the valve.
- Slowly apply the test medium to the inlet space upstream of the valve. A sudden surge in pressure and resulting high flow velocities can damage the valve.
- 3. Open the valve.
- 4. Apply the required test pressure.

- Check the valve for leakage to the atmosphere.
- 6. Depressurize the pipeline section and valve
- Rework any parts that leak and repeat the leak test.

5.4.2 Travel motion

The movement of the actuator stem must be linear and smooth.

- Apply the maximum and minimum control signals to check the end positions of the valve while observing the movement of the actuator stem.
- Check the travel reading at the travel indicator scale.

5.4.3 Fail-safe position

Fail-safe position with pneumatic actuators with integrated springs

- → Shut off the signal pressure line.
- Check whether the valve moves to the fail-safe position (see the 'Design and principle of operation' chapter).

Fail-safe position for electric actuators with fail-safe action

- → Disconnect the supply voltage from the actuator.
- Check whether the valve moves to the fail-safe position (see the 'Design and principle of operation' chapter).

5.4.4 Pressure test

The plant operator is responsible for performing the pressure test.

During the pressure test, make sure the following conditions are met:

- Retract the plug stem to open the valve.
- Observe the maximum permissible pressure for both the valve and plant.





- Unscrew the seat (4) using a suitable tool.
- 8. Apply a suitable lubricant to the thread and the sealing cone of the new seat.
- 9. Screw in the seat (4). Observe tightening torques.
- 10. Apply a suitable lubricant to all the packing parts and to the new plug stem (5). SAMSON recommends replacing the packing as well (see Chapter 9.4.2).
- 11. Slide the new plug with plug stem (5) into the valve body (1).
- Carefully place the valve bonnet (2) over the plug stem onto the body.
- 13. Carefully slide the packing parts over the plug stem extension into the packing chamber using a suitable tool. Observe the proper sequence (see Fig. 9-3).
- 14. Press plug (5) firmly into the seat (4), while fastening down the valve bonnet (2) with the body nuts (14). Tighten the nuts gradually in a crisscross pattern.Observe tightening torques.

10 Decommissioning




